Jeff Baker reported that the College is currently looking into creating staggered schedules for Leadership and Management to begin in the Summer and then potentially increasing the frequency in the Fall. They are still taking precautions as other Colleges nearby went too fast and had issues with Covid, forcing them to stay 100% closed for the Fall. Ultimately, he mentioned that the decision was up to the Board of Trustees, and he indicated that any event being sponsored by the Foundation would be a liability to the Foundation and the College, even if staff is not present. Finally, he reported that the College would be increasing its online offering in the future.

Bill Chunowitz pointed out that a thank you letter from a student who received funding was included in the Committee meeting packet for the Committee's review.
